JACKPOT.COM'S GUESS THE PICK SWEEPSTAKES

In return for the opportunity to participate in the Jackpot.com's Guess the Pick Sweepstakes described herein (the "Sweepstakes"), Rocket Ball, Ltd. (the "Houston Rockets") and Lottomatrix USA LLC d/b/a Jackpot.com ("Sponsor") require your agreement to comply with and be bound by the terms and conditions set forth below (the "Official Rules").

OFFICIAL RULES

- 1. **ENTRY PERIOD.** The Sweepstakes will begin on May 9, 2023, and end on May 15, 2023 (the "Entry Period").
- 2. ELIGIBILITY. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. - 3. **ENTRIES. LIMIT OF ONE (1) ENTRY PER PERSON.** There are two (2) ways to enter the Sweepstakes (each, an "Entry"):
 - <u>Primary Entry Method</u>: To enter the Sweepstakes, an eligible person must properly fill out and submit an official online entry form available via the Formstack provided by the Houston Rockets and/or Sponsor during the Entry Period, including Entrant's name, email address, date of birth, phone number, and a guess as to which lottery pick the Houston Rockets will receive in the first round of the 2023 NBA Draft Lottery.
 - <u>Alternate Entry Method</u>: Alternatively, an eligible person may enter by printing Entrant's name, mailing address (no P.O. Boxes), email address, date of birth, phone number, and a guess as to which lottery pick the Houston Rockets will receive in the first round of the 2023 NBA Draft Lottery on a 3"x5" postcard and mailing it to: Jackpot.com's Guess the Pick Sweepstakes, 1510 Polk Street, Houston, TX 77002, Attn: Liane Fisher. Proof of mailing does not constitute proof of delivery.

Limit of one (1) Entry per person. An eligible Entry shall consist of a completed online entry form, including all required fields and indicating an Entrant's lottery-pick guess, regardless of whether the Entrant correctly predicts the eventual lottery pick. Entries must be received during the Entry Period to be eligible. Any Entry received thereafter or not properly submitted will not be eligible to participate in the Sweepstakes. Any Entrant using multiple accounts to enter will be disqualified from the Sweepstakes and will not be eligible to win a Prize. A person who timely submits a properly completed Entry in accordance with the procedures herein is considered an "Entrant." Winner will be notified on or about May 22, 2023, via email. By participating, each Entrant agrees to these rules and the decisions of the Houston Rockets and/or Sponsor, which shall be final and legally binding in all matters relating to this Sweepstakes. The Houston

Rockets and/or Sponsor reserve the right to conduct a background check of each Entrant and to disqualify any Entrant, effective upon written notice, if such Entrant commits, or has at any time committed, any act or becomes involved in, or has at any time been involved in, any situation or occurrence which act, situation or occurrence tends in the sole opinion of the Houston Rockets and/or Sponsor to subject Entrant, the Houston Rockets and/or Sponsor to any ridicule, contempt or scandal or which, in the sole opinion of the Houston Rockets and/or Sponsor, reflects unfavorably upon the Houston Rockets and/or Sponsor. If any potential Winner cannot be contacted after the first attempt, declines the Prize, or fails to pick up the Prize within two (2) days of being notified that Entrant is a Winner, then such Winner will forfeit the right to be a Winner, and the Houston Rockets and/or Sponsor may select a replacement Winner from among all remaining eligible Entries.

The Winner will receive four (4) VIP Experience tickets to the Houston Rockets 2023 Draft Party (which includes reserved seating and food and non-alcoholic beverages) (the "Prize" with an approximate retail value of \$550). All aspects of the Prize shall be determined by the Houston Rockets in their sole discretion, and any Prize shall be subject to all NBA rules, regulations, guidelines, policies, restrictions, including but not limited to rules related to COVID-19. The Houston Rockets and/or Sponsor shall not be responsible for any expenses associated with any Prize, including but not limited to travel accommodations or transportation expenses. By entering, each Entrant agrees to HOLD HARMLESS AND INDEMNIFY the Houston Rockets, Sponsor, the NBA and its member teams, NBA Properties, Inc., and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, governors, employees, and agents (the "Released Parties") from any and all liability, damages, claims and causes of action (however named or described) with respect to or arising out of (a) Entrant's participation in this Sweepstakes, (b) Entrant's Entry or any registration material on any related website, (c) any typographical or other error in these Official Rules or (d) the receipt, participation in, and/or use of the Prize (or any portion of the Prize) or any replacement prize that may be awarded herein, including any travel associated with the Prize.
- 7. **CONSENT OF USE.** Each Entrant hereby agrees and consents, without further authorization, compensation, or remuneration of any kind, to the editing, modification, replication, publication, and other use of the names, likenesses, photographs, voices, Entries, and the like of each Entrant in any medium, whether now known or hereafter developed, including without limitation, the Houston Rockets and/or Sponsor's website and in any and all advertising, promotions, and other publicity conducted by the Released Parties, and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, owners, governors, employees, and agents, except where prohibited by law. Notwithstanding the generality of the foregoing, each Entrant further assigns any and all rights he or she may have over their Entry to the Houston Rockets and/or Sponsor without further authorization, compensation, or remuneration of any kind.

- 8. **RULES.** All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of the Houston Rockets and/or Sponsor and may be changed from time to time without notice. The Houston Rockets and/or Sponsor reserve the right to cancel or modify the Sweepstakes at any time without notice.
- 9. **DISPUTES.** This Sweepstakes shall be governed by and construed in accordance with the laws of the State of Texas, without regard to principles of conflicts of laws. EACH ENTRANT HEREBY WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THOSE COURTS AND SUBMITS TO THE JURISDICTION OF THOSE COURTS. Each Entrant agrees that any controversy, dispute or claim arising out of, relating to or connected with the Sweepstakes shall be resolved individually, without resort to any form of class action, and exclusively by arbitration, which will be conducted in Houston, Texas in accordance with the Commercial Arbitration Rules of JAMS ("JAMS"), and any judgment on the award rendered by the arbitrator may be entered by any court having jurisdiction thereof. The arbitrator shall be selected by mutual agreement of the parties, if possible, and shall be a resident of Houston, Texas. If the parties fail to reach agreement upon the appointment of an arbitrator within thirty (30) days following receipt by one party of the other party's notice of desire to arbitrate, the arbitrator shall be selected from a list or lists of persons submitted by JAMS. The selection process shall be that which is set forth in the JAMS Commercial Arbitration Rules then prevailing, except that if the parties fail to select an arbitrator from one or more lists, JAMS shall not have the power to make an appointment but shall continue to submit additional lists until an arbitrator has been selected. Under no circumstances will Entrant be permitted to obtain any punitive, incidental, special, consequential, or other damages, including without limitation lost profits (collectively, "Special <u>Damages</u>"); and Entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
- 10. PRIVACY AND MARKETING DISCLAIMER. If Entrant provides a cell phone number, then Entrant consents to be contacted using an auto-dialer for marketing purposes. In the event and to the extent of a conflict between the privacy policies, the NBA's privacy policy shall control.
