

## SEBASTIAN MANISCALCO TICKETS GIVEAWAY SWEEPSTAKES

In return for the opportunity to participate in the for Sebastian Maniscalco Tickets Giveaway Sweepstakes described herein (the “Sweepstakes”), Live Nation Worldwide Inc. (“Sponsor”) and Clutch City Sports & Entertainment, L.P., which operates Toyota Center (the “Arena”) require your agreement to comply with and be bound by the terms and conditions set forth below (the “Official Rules”):

### OFFICIAL RULES

- 1. ENTRY PERIOD.** The Sweepstakes will begin on August 8, 2024, at 12:00 p.m. Central Time (“CT”), and end on August 8, 2024 at 3:30 p.m. CT (the “Entry Period”).
- 2. ELIGIBILITY. NO PURCHASE NECESSARY TO ENTER OR WIN.** Only legal residents of the United States who are 18 years of age or older as of the first day of the Entry Period are eligible to participate in this Sweepstakes, provided they live within the state of Texas or 150 miles of the Houston, TX city limits, excluding residents within 75 miles of either the Dallas, TX or San Antonio, TX city limits. Employees and immediate family members (spouses, parents, siblings and children) of employees of the Arena, Sponsor, Rocket Ball Ltd. (the “Houston Rockets”), the National Basketball Association (the “NBA”) and its member teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, partners, officers, governors, employees, and agents are not eligible to enter. The Sweepstakes is void wherever prohibited or restricted by law.
- 3. ENTRIES.** There are two (2) ways to enter the Sweepstakes (each, an “Entry”):
  - **Facebook Entry Method:** To enter the Sweepstakes via Facebook, entrant must like the post on the official Arena Facebook page promoting the Sweepstakes and tag the person who Entrant would take to the Sebastian Maniscalco show. Entrant must be a registered user of Facebook and follow the Arena account to enter via Facebook.
  - **Alternate Entry Method:** Alternatively, an Entrant may enter the Sweepstakes by sending an email to alyssap@rocketball.com with the subject line “Sebastian Giveaway” and include in the body of the email Entrant’s name, mailing address (no P.O. Boxes), email address, date of birth, phone number, and Entrant’s preferred social media entry method.

Limit of one (1) Entry per person per entry method. Entries must be received during the Entry Period to be eligible. Any Entry received thereafter or not properly submitted will not be eligible to participate in the Sweepstakes. Any Entrant using multiple accounts to enter will be disqualified from the Sweepstakes and will not be eligible to win a Prize. Entries that contain, in the sole discretion of Arena and/or Sponsor, any profane, obscene, vulgar, defamatory, libelous or slanderous material will be disqualified. A person who timely submits a properly completed Entry in accordance with the procedures herein is considered an “Entrant.” **By submitting a properly completed Entry, each Entrant acknowledges that he has read, understands and agrees to be bound by these Official Rules.**

- 4. SELECTION OF WINNER.** One (1) winner (the “Winner”) from Facebook will be selected at random from among all eligible Entries received. Winner will be notified on or before August 8, 2024, via email or the social-media platform Entrant used to enter the Sweepstakes. By participating, each Entrant agrees to these rules and the decisions of Arena and/or Sponsor, which shall be final and legally binding in all matters relating to this Sweepstakes. Arena and/or Sponsor reserve the right to conduct a background check of each Entrant and to disqualify any Entrant, effective upon written notice, if such Entrant commits, or has at any time committed, any act or becomes involved in, or has at any time been involved in, any situation or occurrence which act, situation or occurrence tends in the sole opinion of Arena and/or Sponsor to subject Entrant, Arena and/or Sponsor or their affiliates to any ridicule, contempt or scandal or which, in the sole opinion of Arena and/or Sponsor or their affiliates, reflects unfavorably upon Arena and/or Sponsor or their affiliates. **If any potential Winner cannot be contacted after the first attempt, declines the Prize, or fails to pick up the Prize, then such Winner will forfeit the right to be a Winner, and Arena and/or Sponsor may select a replacement Winner from among all remaining eligible Entries.**
- 5. PRIZE DESCRIPTION; ODDS.** Winner will receive two (2) lower-level tickets to the Sebastian Maniscalco comedy show on August 8, 2024, at the Arena (approximate retail value: \$100) (the “Prize”). All aspects of the Prize, including without limitation the selection of the seat locations, shall be determined by Arena and/or Sponsor in their sole discretion and any Prize shall be subject to all Arena and/or Sponsor rules, regulations, guidelines, policies, restrictions, and to the same rules and regulations as regularly sold tickets, including but not limited to rules related to COVID-19. Arena and/or Sponsor shall not be responsible for any expenses associated with any Prize, including but not limited to food and beverage in any suites, travel accommodations, or transportation expenses. The odds of winning will depend on the number of eligible Entries received. Winner may not sell, assign, transfer, or substitute the Prize (or any portion of the Prize) or redeem the Prize (or any portion of the Prize) for cash value. Winner will be responsible for any federal, state, and local taxes associated with the Prize and for any expenses associated with the Prize. Winner may be required to sign, at the request of and in the sole discretion of Arena and/or Sponsor, a Release, an Affidavit of Eligibility and/or a Prize Acceptance Form to receive the Prize. Arena and/or Sponsor reserve the right to substitute the Prize with any prize of greater or equal value.
- 6. LIMITATIONS ON LIABILITY.** Arena and/or Sponsor shall not be responsible for Entries that are incomplete, improperly submitted, stolen, misdirected, lost, late or damaged. All Entries become the property of Arena and/or Sponsor and will not be

acknowledged or returned. **By entering, each Entrant agrees to HOLD HARMLESS AND INDEMNIFY the Houston Rockets, Arena, Sponsor, the NBA and its member teams, NBA Properties, Inc., and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, governors, employees, and agents (the “Released Parties”) from any and all liability, damages, claims and causes of action (however named or described) with respect to or arising out of (a) Entrant’s participation in this Sweepstakes, (b) Entrant’s Entry or any registration material on any related website, (c) any typographical or other error in these Official Rules or (d) the receipt, participation in, or use of the Prize (or any portion of the Prize) or any replacement prize that may be awarded herein, including any travel associated with the Prize.**

7. **CONSENT OF USE.** Each Entrant hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the editing, modification, replication, publication and other use of the names, likenesses, photographs, voices, Entries and the like of each Entrant in any medium, whether now known or hereafter developed, including without limitation, Arena and/or Sponsor’s website and in any and all advertising, promotions, and other publicity conducted by Arena, Sponsor, or the NBA and its member teams, NBA Properties, Inc., and each of their respective partners, parents, subsidiaries, affiliates, directors, officers, owners, governors, employees, and agents, except where prohibited by law. Notwithstanding the generality of the foregoing, each Entrant further assigns any and all rights he or she may have over his or her Entry to Arena and/or Sponsor without further authorization, compensation or remuneration of any kind.
8. **RULES.** All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of Arena and/or Sponsor and may be changed from time to time without notice. Arena and/or Sponsor reserve the right to cancel or modify the Sweepstakes at any time without notice.
9. **DISPUTES.** This Sweepstakes shall be governed by and construed in accordance with the laws of the State of Texas, without regard to principles of conflicts of laws. **EACH ENTRANT HEREBY WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THOSE COURTS AND SUBMITS TO THE JURISDICTION OF THOSE COURTS.** Each Entrant agrees that any controversy, dispute or claim arising out of, relating to or connected with the Sweepstakes shall be resolved individually, without resort to any form of class action, and exclusively by arbitration, which will be conducted in Houston, Texas, in accordance with the Commercial Arbitration Rules of the American Arbitration Association (“AAA”), and any judgment on the award rendered by the arbitrator may be entered by any court having jurisdiction thereof. The arbitrator shall be selected by mutual agreement of the parties, if possible, and shall be a resident of Houston, Texas. If the parties fail to reach agreement upon the appointment of an arbitrator within thirty (30) days following receipt by one party of the other party’s notice of desire to arbitrate, the arbitrator shall be selected from a list or lists of persons submitted by the AAA. The selection process shall be that which is set forth in the AAA Commercial Arbitration Rules then prevailing, except that if the parties fail to select an arbitrator from one or more lists, AAA shall not have the power to make an appointment but shall continue to submit additional lists until an arbitrator has been selected. Under no circumstances will Entrant be permitted to obtain any punitive, incidental, special, consequential or other damages, including without limitation lost profits (collectively, “**Special Damages**”) to an Entrant; and Entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
10. **FORCE MAJEURE.** Arena and/or Sponsor shall not be responsible for the failure or interruption of any website, webpage, or social media platform mentioned herein, www.rockets.com, any email server, or the cancellation or postponement of an Arena event or any drawing for any reason including, but not limited to, equipment failure or malfunction, electrical service interruption, or any act of God. In addition, in the event that Sponsor or Arena are prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, epidemic, flood, hurricane, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal state or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within the control of Arena and/or Sponsor, Arena and/or Sponsor shall have the right to modify, suspend or terminate the Sweepstakes.
11. **ADDITIONAL DISCLOSURES.** The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram, Twitter, Facebook, or any other social media platform. Each Entrant releases Instagram, Twitter, Facebook, and all other social media platforms mentioned in these Official Rules from any claims, responsibility or liability relating to their participation in this Sweepstakes. Copyright/trademark/service mark infringements are not intended or implied. **By entering the Sweepstakes, each Entrant agrees to receive communications from Arena, Sponsor, and/or the Houston Rockets, subject to opting out when Entrant so desires.**
